

**INC. TOWN OF NORTH JUDSON
GOLF CART PERMIT APPLICATION**

A permit may be issued for a golf cart in the Town of North Judson if all Town requirements are met.

Golf carts may be operated on all streets and alleys under the jurisdiction of the Town of North Judson, with the exception of any highway designated as part of the State highway system (State Road 39 and HWY 10) other than to cross such state highway at its intersection with a local street under the jurisdiction of the Town of North Judson.

- The owner of the golf cart **must** provide proof of liability insurance {\$25,000} at time of application. (attach copy)
- A golf cart operated on the streets and alleys of the Town of North Judson shall at all times be operated by an individual who possesses a valid license to operate a motor vehicle and may operate the cart from dawn to dusk.
- A golf cart must be equipped with a slow-moving emblem or placard, or a flashing red light by Indiana Law
- An officer from the North Judson Police Department **must** complete an inspection of the golf cart.
- All traffic regulations applicable to the operation of motor vehicles on streets, roads and highways of the State of Indiana and the Town of North Judson shall apply to the operation of a golf cart on the streets and alleys of the Town of North Judson.
- The fee for the Golf Cart Permit is **\$25.00 annually**. The permit expires December 31.
- The permit sticker shall be visible from the rear and not altered or removed from the golf cart.
- This is not a comprehensive list of rules, regulations, or laws. A complete copy of the town's ordinance 2012-08 is available at the Clerk – Treasurer's Office, 204 Keller Avenue, North Judson, IN 46366 for a nominal fee.
- Applications are available at the Clerk's Office. The top section shall be completed and returned to the clerk. The Police will make contact with the applicant to complete inspection section. Applicant shall return to the Clerk to pay permit fee and receive Permit Sticker.
- **ALL PERMITS EXPIRE ON DECEMBER 31.** New permits may not be purchased prior to November 15th of the expiring year.
